

RESOLUTION NO. R-254127

(R. 81-2093)

WHEREAS, on April 27, 1981, the Secretary of the Interior issued a final Notice of Sale for the exploration, development and production of oil and natural gas for certain offshore areas adjacent to Central and Northern California; and

WHEREAS, the State of California and many local coastal cities and counties have expressed opposition to portions of this lease-sale; and

WHEREAS, the Outer Continental Shelf Lands Act requires that the Federal Government balance the interests of local governments affected by offshore drilling for oil and gas; and

WHEREAS, the State of California and certain state agencies have filed a complaint for declaratory relief in the United States District Court for the Central District of California seeking a declaration of their rights under the Outer Continental Shelf Lands Act; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that this Council expresses its support for the State of California and the other California agencies and local jurisdictions in their opposition to those portions of the proposed OCS Lease-Sale No. 53 described in their complaint.
