

RESOLUTION NO. R-254136

WHEREAS, Commercial Janitorial Services was the low bidder on Bid No. 3790, furnishing janitorial services at the Central Library; and

WHEREAS, Commercial Janitorial Services furnished a guarantee of good faith in the amount of \$1,000, at the time it submitted its bid; and

WHEREAS, Commercial Janitorial Services has notified the City that it will not perform the contract if awarded; and

WHEREAS, the difference between Commercial Janitorial Services' bid and the next low bid is \$1,001.31; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

1. That Commercial Janitorial Services be declared in default of the terms and conditions of Bid No. 3790, and its \$1,000 guarantee of good faith be forfeited.

2. That the second low bid of Orange Coast/ Ubiquity, Inc., is hereby accepted and a contract for furnishing Janitorial Services at the Central Library as may be required for a period of one (1) year beginning April 1, 1981, through March 31, 1982, is hereby authorized, at an annual cost

of \$50,501.90; terms net 10 days, with an option to renew for three (3) additional one (1) year periods at prices not to exceed 9.5% of prices in effect at the end of the initial year.
