
BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the City Manager be and he is hereby authorized and empowered to execute, for and on behalf of said City, Utilities Agreement No. 24647 with the STATE DEPARTMENT OF TRANSPORTATION for rearrangement of water facilities on Interstate 15 between 0.4 mile south and 0.7 mile north of Route 274, under the terms and conditions set forth in the agreement on file in the office of the City Clerk as Document No. RR-254153.

BE IT FURTHER RESOLVED, that the City Auditor is hereby authorized to transfer \$30,750 within Water Revenue Fund 41502 from the Unallocated Reserve 70679 to CIP 73-024, Water Construction Outlay 70592.

BE IT FURTHER RESOLVED, that the expenditure of \$46,750 is hereby authorized from CIP 73-024 solely and exclusively for the above purpose.
