Adopted on MAY 11 1981

BE IT RESOLVED, by the Council of the City of San Diego, as follows:

That the plans on file in the office of the City Clerk as Document No.

00-15512 be hereby amended or clarified to show the following conditions:

1. The alignment of Carmel Valley Road shall be as set forth in the plans but that the width of the paved part of the road should be no wider than 50 feet.
2. The portion of Carmel Valley Road from I-5 to the City limits shall be posted for 35 miles per hour, such speed limits are subject to approval by the City Traffic Engineer.
3. The City Traffic Engineer will evaluate the possibility of installing a traffic signal or a three-way stop sign at the corner of Portofino.
4. There will be no dumping of excess fill material into the lagoon.
5. Parking will be prohibited along the south side of Carmel Valley Road from I-5 to Portofino but not beyond.
6. The bike path will be retained.
7. Install reflector-type striping along the improvement area from Portofino to I-5 showing the width of the road.
