

RESOLUTION NO. R-254165 (R.81-1941)

WHEREAS, the San Diego Housing Commission has requested that the City convey four parcels of City-owned property, consisting of approximately 1.41 acres, located in the area of Venus and Camulos, Famosa and Valeta, Mason and I-5, and Fairmount and Laurel, to the Housing Authority of The City of San Diego so that the sites can be most expeditiously utilized for the development of approximately 32 units of low-income rental housing adaptable to the needs of handicapped tenants; and

WHEREAS, the conveyance of said parcels to the Housing Authority will further the City's efforts to provide low-income housing opportunities for handicapped City residents; NOW THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that the Mayor and the City Clerk are hereby authorized and empowered to execute Grant Deeds conveying all of the City's interest in the properties located in the area of Venus and Camulos, Famosa and Valeta, Mason and I-5, and Fairmount and Laurel, as more particularly described in said Deeds, copies of which are cumulatively on file in the office of the City Clerk as Document No. R-254165-1#4, to the Housing Authority of The City of San Diego, for the purpose of utilizing said properties for the development and operation of adaptable housing units which are to be available to handicapped persons and families of low-income.
