BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the City Manager be and he is hereby authorized and empowered to execute, for and on behalf of said City, an agreement with the COMMUNITY CRISIS CENTER, a nonprofit corporation, to construct interior improvements to leased facilities at 5079-5083 1/2 Logan Avenue, under the terms and conditions set forth in the agreement on file in the office of the City Clerk as Document No. R-254174.

BE IT FURTHER RESOLVED, that the City Auditor is hereby authorized to transfer \$50,000 from C.D.G.B. Fund 18517, Department 5994, Org. 9401 (contingencies) to Fund 18517, Department 5987, Org. 8706.

BE IT FURTHER RESOLVED, that the expenditure of \$50,000 is hereby authorized from C.D.B.G. Fund 18517, solely and exclusively for the purpose of funding the construction of interior improvements to the Community Crisis Center and related costs.
