BE IT FURTHER RESOLVED, that the City Manager is hereby authorized to execute a contract with the lowest responsible and reliable bidder for

CONSTRUCTION OF BAY BRIDGE (CHICANO) PARK IMPROVEMENTS - PHASE IV.

BE IT FURTHER RESOLVED, that the expenditure, not to exceed \$233,000.00 from CDBG Fund 18516, and an amount not to exceed \$15,000.00 from Sewer Revenue Fund 41506, CIP 44-001 Annual Allocation Main Replacements; and an amount not to exceed \$3,540.00 from CIP 58-007, Overhead and Other City Costs for Projects Funded by Federal Grant, of the City of San Diego is hereby authorized solely and exclusively for providing funds for said project and related costs, and authorizing the Auditor and Comptroller, upon advice from the administering department, to transfer excess budgeted funds, if any, to the appropriate reserves.
