

RESOLUTION NO. R-254214 (R.81-2035)

WHEREAS, a sewer easement was acquired for an earlier development in the area of the subdivision now known as MISSION BAY VALLEY ESTATES; and

WHEREAS, a portion of the easement was abandoned in 1976 in connection with the recording of MISSION BAY VALLEY ESTATES; and

WHEREAS, a portion of the sewer easement was omitted from the abandonment; and

WHEREAS, the aforementioned easement has had a five (5) year period of non-use; and

WHEREAS, the City has no present or prospective use for the easement and the City Manager has recommended that the City abandon its interest therein; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

That the City of San Diego, by this resolution, does hereby abandon whatever right, title or interest it may have in the sewer easement, as more particularly shown on Drawing No. 13890-B on file in the office of the City Clerk as Document No. RR-254214-1, which is by this reference incorporated herein and made a part hereof.

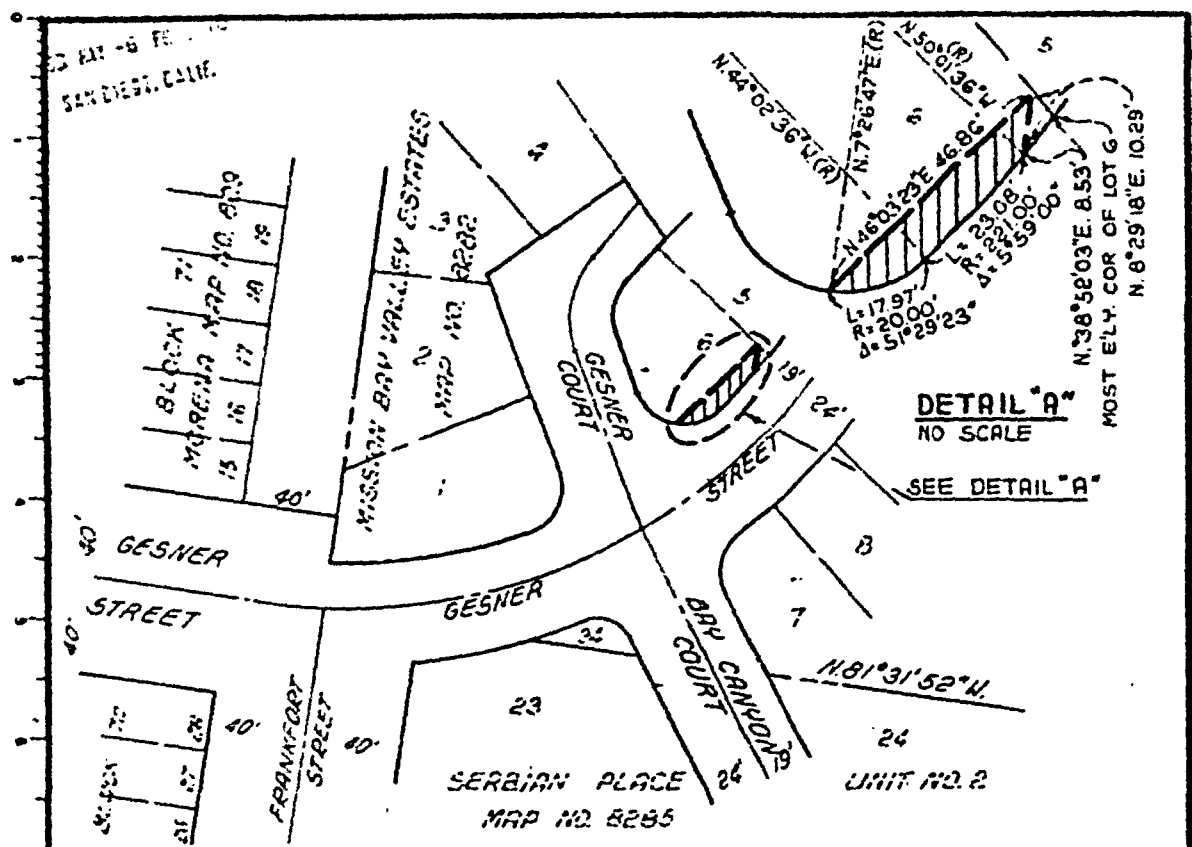
That the City Clerk shall cause a certified copy of this resolution attested by him under seal, to be recorded in the office of the County Recorder.

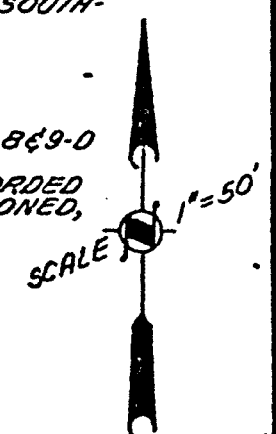
