APPROVING MAP OF BABICH-UNGER SUBDIVISION AND ACKNOWLEDGING
RECEIPT OF SUBDIVIDER'S ASSURANCE OF COMPLIANCE WITH THE
AFFIRMATIVE MARKETING PROGRAM

BE IT RESOLVED, by the Council of The City of San Diego, as follows:


Said Council hereby finds that certain map surveyed by THOMAS H. SHUTTLEWORTH, a Licensed Land Surveyor, entitled "BABICH-UNGER SUBDIVISION Being a subdivision of Lots 1, 2 and 3 in Block 140 of University Heights, in the City of San Diego, County of San Diego, State of California, according to Map thereof No. 558, filed in the office of the County Recorder of San Diego County August 6, 1888, also that portion of the south 10.00 feet of Tyler Avenue adjoining said land on the north, which was closed to public use April 30, 1917 by Resolution No. 22699 of the Common Council of The City of San Diego.", is made in the manner and form prescribed by law and conforms to the surrounding surveys; that said map and the subdivision of land shown thereon is hereby approved and accepted.

The Clerk of said City is hereby authorized and directed to endorse upon said map, as and for the act of the Council, that said Council has approved said subdivision map.

BE IT FURTHER RESOLVED, that said Council hereby acknowledges receipt of assurance from the subdivider, BABICH-UNGER PARTNERSHIP, that said subdivider will comply with the Affirmative Marketing Program as outlined in Document No. 757438, on file in the Office of the City Clerk, and in reliance on said assurance does hereby accept the final map of BABICH-UNGER SUBDIVISION.

The Clerk of said City is hereby directed to transmit said map to the Clerk of the Board of Supervisors of the County of San Diego, California.
