

WHEREAS, there were relinquished to The City of San Diego certain abutter's rights of access in and to LA JOLLA VILLAGE DRIVE from Parcel 2 of Parcel Map No. 10109, filed in the office of the County Recorder; and

WHEREAS, THEODORE E. GILDRED and LOMAS SANTA FE, INC. have requested that the City revest these abutter's rights of access in the property to allow better utilization of the land; and

WHEREAS, said abutter's rights of access were acquired at no cost and there will be no charge for the revestment of access rights; and


WHEREAS, said abutter's rights of access are no longer needed by the City and should be revested in the property; NOW, THEREFORE,

1. That the Mayor and the City Clerk of said City be, and they are hereby authorized and empowered to execute, for and on behalf of The City of San Diego, a quitclaim deed, a copy of which is on file in the office of the City Clerk as Document No. RR-254296, quitclaiming to THEODORE E. GILDRED and LOMAS SANTA FE, INC., the revestment of those abutter's rights of access in and to LA JOLLA VILLAGE DRIVE from Parcel 2 of Parcel Map No. 10109, as more particularly described in said quitclaim deed.

2. That the City Clerk of said City be, and he is hereby authorized and directed to deliver said deed and a certified copy of this resolution to the Engineering and Development Department for further handling.
