WHEREAS, two unnamed 40-foot streets have been impassable for five consecutive years and no public money has been expended for maintenance; and

WHEREAS, the two unnamed streets are not accurately set forth in the deed or map description and cannot accurately be plotted; and

WHEREAS, only that portion of the unnamed streets within the subdivision boundary of Sierra Del Mar are being vacated; and



BE IT RESOLVED, by the Council of The City of San Diego, as follows:



- 2. That the City Clerk shall cause a certified copy of this resolution, with drawing, attested by him under seal, to be recorded in the office of the County Recorder.


