That the Mayor and the City Clerk are hereby authorized and empowered to execute, for and on behalf of The City of San Diego, a quitclaim deed, a copy of which is on file in the office of the City Clerk as Document No. RR- 254304, quitclaiming to FARGO INDUSTRIES CORPORATION, a California corporation, all the City's right, title and interest in the water easements, as more particularly described in said quitclaim deed.
