BE IT RESOLVED, by the Council of The City of San Diego as follows:

1. The Mayor and City Clerk is hereby authorized to execute for and on behalf of the City a quitclaim deed to RUSSELL V. GRANT, as Trustee, quitclaiming any right, title or interest in or to an easement of ingress and egress over a portion of Pueblo Lot 1246 which may have been acquired by prescription or by that condemnation action entitled The City of San Diego v. Alta S. Grant, Superior Court No. 253163, as more particularly set forth in that quitclaim deed on file in the office of the City Clerk as Document No. RR-254334-1.

2. The City Manager is hereby authorized to execute an easement agreement by which a specific easement is granted to the City over a portion of Pueblo Lot 1246, according to that easement agreement on file in the office of the City Clerk as Document No. RR-254334-2.

3. The recordation of both instruments shall be accomplished in the order set forth above by July 1, 1981, pursuant to a letter from Russell V. Grant, as Trustee, to The City of San Diego dated April 27, 1981 and conditions therein contained, as amended by letter dated May 27, 1981, both on file in the office of the City Clerk as Document No. RR-254334-3.
