WHEREAS, the Suggestion Awards Committee has heretofore made certain recommendations to this Council; and

WHEREAS, the Council has reviewed said recommendations as well as the suggestions as presented; NOW THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, as follows:

That the following suggestion awards are hereby approved and the Auditor and Comptroller is hereby directed to issue warrants out of the General Fund for the following suggestions:

<u>NAME</u>	<u>DEPARTMENT</u>	<u>AMOUNT</u>	<u>SUGGESTION</u>
John L. Brewer	Fire	\$1,925	Mr. Brewer is a Fire Captain. He suggested that the Parts Room in the Repair Facility be relocated in order that the parts could be housed in one location. This improvement will provide for greater accountability of parts and a resultant decrease in inventory shrinkage. This is expected to save \$12,841.00 in the first year. This is a partial award pending a final 12-month review.
Donald W. Pio	Park and Recreation	\$1,830	Mr. Pio is an Equipment Operator in the Central Division. He suggested that the method of attaching the cutting blades on lawn renovators be modified to lessen premature damage of the cutting shafts. This is expected to save \$10,535.00 in the first year. This is a partial award pending a final 12-month review.
Henry C. Stoker	Police	\$ 820	Mr. Stoker is an Equipment Service Supervisor in the Support Services Bureau. He suggested that used tires be sold to a recapper rather than discarded. This is expected to increase the City's revenue by \$5,475 per year. This is a partial award pending a final 12-month review.
Daniel Karsh Larry L. Griffin	Police	\$ 695	Mr. Karsh is a Sergeant and Mr. Griffin is a Police Officer in the Traffic Services Program. They suggested that a provision for a 10% discount in tow fees be included in the City's tow company contracts. This is expected to save \$4,640 in the first year. This is a partial award pending a final 12-month review.
