WHEREAS, the Suggestion Awards Committee has heretofore made certain recommendations to this Council; and

WHEREAS, the Council has reviewed said recommendations as well as the suggestions as presented; NOW THEREFORE,

That the following suggestion awards are hereby approved and the Auditor and Comptroller is hereby directed to issue warrants out of the General Fund for the following suggestions:

<u>NAME</u>	<u>DEPARTMENT</u>	<u>AMOUNT</u>	<u>SUGGESTION</u>
Rita B. Andrews	City Clerk	\$ 110	Ms. Andrews is a Senior Stenographer. She developed a simplified method of processing unanimous consent resolutions. This is expected to save \$362 annually in labor costs.
Glen F. Jarvis	Water Utilities	\$ 100	Mr. Jarvis is a Water Utility Worker in the Systems Division. He suggested that steps be attached to the bed of the 1800 Series Dump Trucks. Although savings were difficult to estimate, this was considered to be a significant employee safety improvement.
John F. Casey Thomas H. Herzberger	Building Inspection	\$ 85	Mr. Casey is a Building Technician II and Mr. Herzberger is an Assistant Civil Engineer. One year ago they earned a partial award of \$75 for their suggestion that a plan submission checklist be implemented. One year's experience has shown a saving of \$1,585. This is the remainder of their award.
Alfred Szymansky	General Services	\$ 80	Ms. Szymansky is a welder in the Equipment Division. One year ago he earned a partial award of \$80 for his suggestion that wear strips be installed on the bottom and sides of the hopper on trash trucks. One year's experience has shown a savings of \$2,428. This is the remainder of his award.
Larry W. Redden	Fire	\$ 70	Mr. Redden is a Fire Engineer. He suggested that the maintenance schedule for reserve apparatus be adapted proportionately for lower mileage. This is expected to save \$446 annually in time and material. This is a partial award pending a final 12-month review.
