

RESOLUTION NO. R-254340Adopted on JUN 2 1981

WHEREAS, the Suggestion Awards Committee has heretofore made certain recommendations to this Council; and

WHEREAS, the Council has reviewed said recommendations as well as the suggestions as presented; NOW THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, as follows:

That the following suggestion awards are hereby approved and the Auditor and Comptroller is hereby directed to issue warrants out of the General Fund for the following suggestions:

<u>NAME</u>	<u>DEPARTMENT</u>	<u>AMOUNT</u>	<u>SUGGESTION</u>
Daniel Mata	Park and Recreation	\$ 65	Mr. Mata is an Equipment Operator I in the Central Division. One year ago he earned a partial award of \$65 for his suggestion that the front of the pivot bar on the Ransomes mowers be drilled and tapped. One year's experience has shown a savings of \$1,310. This is the remainder of his award.
Sammy A. Jeromin	Fire	\$ 50	Mr. Jeromin is a Fire Fighter in Support Services. He suggested that leather chin straps on fire fighter's helmets be replaced with nylon straps. This is expected to save \$500 in material costs annually.
John A. Wright	General Services	\$ 50	Mr. Wright was an Equipment Mechanic in the Equipment Division when he made the suggestion to convert an out-of-service vehicle to a yard service vehicle. Although savings were difficult to estimate this was considered to be a significant employee safety improvement.
Arthur L. Monett	Water Utilities	\$ 50	Mr. Monett is a Waste Water Plant Operator in the Water Quality Division. He suggested that non-skid stripping be installed on the stairs which lead to the pump level at Pump Stations #1 and #2. Although savings are difficult to estimate, this was considered to be a significant employee safety improvement.
Mona S. Vallon	General Services	\$ 50	Ms. Vallon is a stock clerk in the Equipment Division. She suggested that a list of stock numbers and amounts received be compiled. This is expected to save \$165 in the first year in labor costs.
