That Change Order No. 1, dated April 7, 1981, heretofore filed with the City Clerk of said City as Document No. RR- 254380, issued in connection with the contract between The City of San Diego and Long, Marker & Howley Construction Company for the CONSTRUCTION OF WATERMAIN REPLACEMENT GROUP 425, said contract having been filed in the office of the City Clerk as Document No. RR-253126, be and the same is hereby approved; and the changes therein set forth, amounting to a net increase in the contract price of \$25,650, be and the same are hereby approved.

BE IT FURTHER RESOLVED, that the City Auditor and Comptroller are hereby authorized to transfer \$25,650 within Sewer Revenue Fund (41506) from CIP 46-009 South Bay/Point Loma Wastewater Treatment Plant (70292) to Sewer Construction Outlay (70492).

BE IT FURTHER RESOLVED, that the additional expenditure of \$25,650, is hereby authorized by the City Auditor and Comptroller, from the Sewer Revenue Fund (41506) solely and exclusively for the purpose of executing this change order.
