WHEREAS, the City Council has actively supported voluntary ridesharing as a widely accepted, low-cost strategy to conserve energy, relieve traffic congestion, decrease parking demand and reduce air pollution; and

WHEREAS, several legislative bills have been introduced in the State Legislature to provide incentives and remove legal impediments to ridesharing; and

WHEREAS, the overall effect of these proposals would be to increase the environmental, economic and energy conservation benefits that can be achieved from greater public participation in various forms of ridesharing; and

WHEREAS, after due consideration and analysis, it is deemed appropriate to declare support for the legislative proposals so offered; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, that this City Council, for and on behalf of itself and the people of the City of San Diego does hereby express its support for Senate Bill 321 (Alquist), and Assembly Bills 548, 549 and 550 (Ryan) and in furtherance thereof, urges favorable action by the California Legislature.
