

RESOLUTION NUMBER R- 254404

Adopted on JUN 10 1981

WHEREAS, the issue of shoreline erosion has received much attention last year as several sections of San Diego region shoreline have experienced erosion problems; and

WHEREAS, a number of cities, including Del Mar, Imperial Beach, Oceanside and San Diego have taken actions to remedy their individual erosion problems; and

WHEREAS, recognizing the area's beaches to be a regional resource, the cities have jointly sought an answer to shoreline erosion problems through SANDAG; and

WHEREAS, SANDAG appointed a task force of shoreline erosion experts in 1980 to evaluate erosion problems and make recommendations as to those remedial actions which may be taken; and

WHEREAS, the task force submitted a preliminary report recommending that there be established a regional agency with the technical and financial capabilities to deal with coastal erosion on a regional basis; and

WHEREAS, after due consideration, it was decided to use an existing agency to conduct the studies; and

WHEREAS, a comprehensive study of the coastline has not been conducted but rather small portions have been studied; and

WHEREAS, a comprehensive study would provide an evaluation of the entire shoreline and enable the shoreline to be preserved as a unit, allowing individual jurisdictions to consider the impact of their past or future erosion actions on other sections of the shoreline; and

WHEREAS, it has been recommended that the Army Corps of Engineers (herein called "Corps") conduct the study which would be conducted over a period of five years, the time necessary to collect data during various tide and wave conditions; and

WHEREAS, SANDAG subcommittee members met with San Diego area legislators and Corps staff in Washington, D.C., in February, 1981, to discuss the comprehensive study and request a Congressional appropriation to the Corps for the study and early indications are that the Corps is capable and willing to conduct the study; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, that this City Council does hereby declare its support for the efforts of SANDAG and its Beach Erosion Subcommittee in seeking Congressional and U. S. Army Corps of Engineers assistance and support for a comprehensive shoreline erosion study.

BE IT FURTHER RESOLVED, that support is hereby further declared for SANDAG's proposal that its Beach Erosion Subcommittee be elevated to a standing committee to continue its efforts in the initiation, coordination and implementation of the shoreline erosion study.
