

RESOLUTION OF INTENTION NO. R- 254430

Adopted on JUN 15 1981

A Resolution Electing to Proceed Under the Provisions of the Public Streets, Highways, and Service Easements Vacation Law, Declaring the Intention of the City Council to Vacate Quimby Street North of Plum Street Adjacent to Lot 6, Block 135, and Lot 5, Block 150, of Roseville Subdivision, and Fixing a Time and Place for Hearing Thereof.

BE IT RESOLVED, by the Council of The City of San Diego, that the public interest and convenience of said City require the vacation of a portion of the street hereinafter mentioned; and in connection therewith require the reservation of certain easements for Quimby Street north of Plum Street adjacent to Lot 6, Block 135, and Lot 5, Block 150, of Roseville Subdivision in the area covered by such street.

EE IT FURTHER RESOLVED, that it is the intention of said Council to order the vacation of Quimby Street north of Plum Street adjacent to Lot 6, Block 135 and Lot 5, Block 150, of Roseville Subdivision, as more particularly shown on Drawing No. 15242-B on file in the office of the City Clerk as Document No. RR- 254430 .


The Council hereby elects to proceed, in making said vacation, under the provisions of the "Public Streets, Highways, and Service Easements Vacation Law."

The Council hereby fixes 2:00 p.m. July 13, 1981 in the Council Chambers on the twelfth floor of the City Administration Building, Charles C. Dail Concourse, 202 "C" Street, in said City of San Diego, as the time and place for hearing all persons interested in or objecting to the proposed vacation.

That The Daily Transcript, a daily newspaper published and

circulated, and of general circulation, in the said City of San Diego, be, and it is hereby designated as the newspaper in which the Street Superintendent of said City shall cause to be published, in the manner and form required by law, notice of the passage of this Resolution of Intention, and the Street Superintendent is hereby directed to cause notices of the passage of this resolution to be posted in the manner and form required by law and to cause a notice similar in substance to be published in said newspaper in the manner required by law.
