BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the City Manager be and he is hereby authorized and empowered to execute, for and on behalf of said City, an agreement with the SAN DIEGO COUNTY ASSOCIATION FOR THE RETARDED, a nonprofit corporation, in which the Association agrees to engage the services of an architect to assist the City in the construction of a six thousand (6,000) square foot addition to the Arrow Center located at 3030 Market Street, San Diego, under the terms and conditions set forth in the agreement on file in the office of the City Clerk as Document No. RR-254437.

BE IT FURTHER RESOLVED, that the expenditure of \$122,000 is hereby authorized from C.D.B.G Fund 18517, Department 5988, Org. 8813, solely and exclusively for the purpose of constructing the 6,000 square foot addition and related costs.
