BE IT FURTHER RESOLVED, that the City Auditor and Comptroller is hereby authorized to transfer \$250 from CIP 90-245, Capital Outlay Unallocated Reserve, to CIP 39-004, Miscellaneous Parcels for Right-of-Way, Open Space and Other Public Purposes.

BE IT FURTHER RESOLVED, that the expenditure in the sum of \$250 from Capital Outlay Fund, CIP 39-004, for acquisition costs and related expenses is hereby authorized and approved.
