That the City Manager be and he is hereby authorized and empowered to execute, for and on behalf of The City of San Diego, an Agreement to Purchase Tax Deeded Property with the COUNTY OF SAN DIEGO, affecting a portion of Rancho de la Nacion Morrill Map, located adjacent to Skyline Drive, east of Deerrock Place in the Southeast San Diego area, under the terms and conditions set forth in that Agreement to Purchase Tax Deeded Property on file in the office of the City Clerk as Document No. RR- 254441 .

BE IT FURTHER RESOLVED, that the City Auditor and Comptroller is hereby authorized to transfer \$2,030 from CIP 90-245, Capital Outlay Unallocated Reserve, to CIP 39-004, Miscellaneous Parcels for Right-of-Way, Open Space and Other Public Purposes.

BE IT FURTHER RESOLVED, that the expenditure in the sum of \$2,030 from Capital Outlay Fund, CIP 39-004, for acquisition costs and related expenses is hereby authorized and approved.
