That the Personnel Director be and he is hereby authorized and empowered to execute, for and on behalf of said City, a modification to contract 8013-8113 with the SAN DIEGO REGIONAL EMPLOYMENT AND TRAINING CONSORTIUM (RETC) for the SAN DIEGO REGIONAL EMPLOYMENT PROGRAM (REGY) to increase the funding level of said agreement from \$1,712,000 to \$2,052,000 to provide employment and training opportunities for 340 additional youth, under the terms and conditions set forth in the Agreement on file in the office of the City Clerk as Document No. RR- 254453 .

BE IT FURTHER RESOLVED, that the expenditure in the sum of \$340,000.00 from Fund 18415 CETA 2B 81 REGY, is hereby authorized, solely and exclusively for the purpose of providing funds for the above program.


