APPROVING MAP OF ELJO VISTA SUBDIVISION

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

Said Council hereby finds that certain map surveyed by BYRL D. PHELPS, a Registered Civil Engineer, entitled " ELJO VISTA Being a subdivision of Lots 5 and 6 of Seedorf Heights Unit No. 2, in the City of San Diego, County of San Diego, State of California, according to Map thereof No. 3107, filed in the office of the County Recorder of San Diego County, July 1, 1954, excepting therefrom that portion dedicated for public street by Resolution No. 181123, recorded August 26, 1964 as File No. 155509 of Official Records., " is made in the manner and form prescribed by law and conforms to the surrounding surveys; that said map and the subdivision of land shown thereon is hereby approved and accepted.

BE IT FURTHER RESOLVED, that said Council hereby accepts on behalf of The City of San Diego, a municipal corporation, the easement with the right of ingress and egress for the construction and maintenance of sewer and drainage facilities, as granted and shown on said map and subject to the conditions set forth thereon.

The Clerk of said City is hereby authorized and directed to endorse upon said map, as and for the act of the Council, that said Council has approved said subdivision map and that the easement with the right of ingress and egress for the construction and maintenance of sewer and drainage facilities, as granted and shown on this map within this subdivision, is accepted on behalf of The City of San Diego, a municipal corporation, as above stated.

Clerk of the Board of Supervisors of the County of San Diego.
