

RESOLUTION NUMBER R- 254487

Adopted on JUN 22 1981

WHEREAS, HR 3314 has been introduced in the Congress and referred to the Committee on Government Operations; and

WHEREAS, the bill will provide for payments in lieu of taxes to be made by the United States to local governments for property exempt from property taxation under federal law which is located within the jurisdiction of the local government and owned by the United States, a foreign government, or an international organization; and

WHEREAS, to receive payments under this bill for any fiscal year, local governments make application to the Administrator of General Services, identifying all eligible property, determining the value such property would be assessed if such property were subject to property taxes, at what tax rate, and at what amount; and

WHEREAS, the bill will cover all U. S. government buildings and land which are not included in the open space payment in Lieu of Taxes Act of 1976; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, California, that this City Council, for and on behalf of itself and all the citizens of San Diego, does hereby express to the Congress of the United States its support for HR 3314, the National Payments in Lieu of Taxes Act of 1981.

BE IT FURTHER RESOLVED, that the City Clerk is hereby directed to forward a copy of this resolution to the City of San Diego's Washington representative for the widest distribution to appropriate legislators.
