That the City Manager be and he is hereby authorized and empowered to execute, for and on behalf of said City, a First Amendment to Agreement with GEORGE S. NOLTE & ASSOCIATES to provide professional engineering services in connection with the realignment of Harbor Drive from Fifth Avenue to Kettner Boulevard, under the terms and conditions set forth in the First Amendment to Agreement on file in the office of the City Clerk as Document No. RR- 254500.

BE IT FURTHER RESOLVED, that the City Auditor and Comptroller is hereby authorized to transfer the sum of \$9,200 within Water Revenue Fund 41502 from the Unallocated Reserve (70679) to CIP 73-083, Annual Allocation for Main Replacement (70647).

BE IT FURTHER RESOLVED, that the expenditure of \$9,200 is hereby authorized from Water Revenue Fund 41502, CIP 73-083, solely and exclusively for this project.
