Wayne L. Ramsey	Treasurer	\$ 180	Mr. Ramsey is a Supervising Field Representative. He suggested that the status of businesses be determined before the delinquent business license renewal cards are mailed. This is expected to save \$1,200 in the first year in postage costs. This is a partial award pending a final 12-month review.
Robert L. Davis	General Services	\$ 120	Mr. Davis is a Plumber Supervisor in the Buildings Division. One year ago he earned a partial award of \$75 for his suggestion to modify the hook-ups to the water heaters at the Balboa Park Club. One year's experience has shown a savings of \$1,941. This is the remainder of his award.
William A. Nelson	Police	\$ 120	Mr. Nelson is a Police Officer. One year ago he earned a partial award of \$100 for his suggestion to use filmstrips as classroom aids in the school safety patrol program rather than easel displays. One year's experience has shown a savings of \$2,286. This is the remainder of his award.
Alison M. Gonzales	Planning	\$ 95	Ms. Gonzales was a Senior Stenographer in the Planning Department. One year ago she earned a partial award of \$40 for her suggestion to eliminate the clerical time spent at the Community Planners' meetings. One year's experience has shown a savings of \$447. This is the remainder of her award.
