WHEREAS, the Redevelopment Agency of the City of San Diego ("Agency") has undertaken certain redevelopment projects in the Centre City area; and

WHEREAS, the Agency has adopted budgets for those projects for Fiscal Year 1981-82, such budgets being on file with the City Clerk as Document No. 25451 and with the Secretary of the Agency as Document No. 8/9; and

WHEREAS, those budgets identify as revenue sources certain City funds including Four Hundred Thousand Dollars (\$400,000) of transient occupancy tax funds for the continued planning, legal, financial and administrative activities relative to a new convention center facility;

NOW THEREFORE, BE IT RESOLVED as follows:

- 1. That transient occupancy tax funds in the amount of Four Hundred Thousand Dollars (\$400,000) are hereby appropriated from the New Convention Facility Fund 10225 for transfer to the Redevelopment Agency.
- 2. That the City Auditor and Comptroller is hereby authorized and directed to transfer such funds to the Agency.
- 3. That such contributions to the Agency are to be recorded as interest bearing loans to the Agency, repayable from tax increment revenues or other revenues.
- 4. That in the event that the Agency desires to issue bonds, notes, or other instruments of indebtedness of the Agency to carry out these redevelopment projects, then any indebtedness of the Agency to the City, including any interest accrued thereon, shall be deemed not to be a first pledge of tax increment allocations received by the Agency pursuant to Health and Safety Code, Section 33670; and any indebtedness of the Agency to the City, including any

interest accrued thereon, shall be subordinate to any pledge of tax increments to bondholders or the holders of other such instruments of indebtedness.
