That the acceptance by the City Manager of that easement deed of ELLEN BROWNING SCRIPPS DAVIS, executed in favor of The City of San Diego, bearing date of April 6, 1981, a copy of which is on file in the office of the City Clerk as Document No. RR- 254542, granting to said City an easement for a public sewer or sewers, for the purpose of relocation of a sewer line in connection with proposed improvements to I-163 by the State Department of Transportation, in a portion of the Southwest Quarter of Section 5, Township 15 South, Range 2 West, San Bernardino Meridian, as more particularly described in said deed, be and the same is hereby approved.

BE IT FURTHER RESOLVED that the expenditure of not to exceed \$1,500 from Sewer Revenue Bond Fund 41506, CIP 43-004, Annual Allocation, Freeway Relocation, is hereby approved.
