Dail Community Concourse Parking Facility at an estimated total cost for the three-year period of \$232,570, under the terms and conditions set forth in that contract on file in the office of the City Clerk as Document No. RR-254554.

BE IT FURTHER RESOLVED, that the expenditure of \$232,570 from the Municipal Parking Garage Fund is hereby authorized and approved, subject to said funds being available at the times called for payment pursuant to the contract.
