WHEREAS, the City Council approved the concept of a computerized criminal justice information retrieval system (JURIS) for the City Attorney's office in fiscal year 1980; and

WHEREAS, the installation and renovation of facilities has been an on-going project since that time; and

WHEREAS, the computerized aspect of the system has been in operation for a year with extremely satisfactory results in terms of operational effectiveness; and

WHEREAS, the renovation of the facilities has proceeded at a slower pace but is approaching completion within the next few months; and

WHEREAS, it is now deemed necessary to take appropriate action to authorize the expenditure of those funds required to complete the renovation of the Criminal Division facilities; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, that the City Attorney and City Manager be and they are hereby authorized to take those actions necessary to complete the renovation of the Criminal Division facilities to modify work flow design in order to fully accommodate the computerized JURIS operation and complete the accompanying filing system.

BE IT FURTHER RESOLVED, that the Auditor and Comptroller be and he is hereby authorized to expend the sum of \$34,000 for the above purpose.
