BE IT FURTHER RESOLVED, that the expenditure in the sum of \$36,314.00 from 19624 Human Care Services - 1982 is hereby authorized, solely and exclusively, for the purpose of providing funds for the above program, contingent upon approval of the Fiscal 1982 Appropriation Ordinance.
