WHEREAS, the City of San Diego has in force an agreement, as amended, with Ann Shanahan Walsh, an individual, to provide a services entitled "Family Referral Program"; and

WHEREAS, said agreement is on file in the office of the City Clerk as Document No. RR-252766, as amended by Document No. C-00572; and

WHEREAS, the City Council has determined during budget deliberations to terminate said program, having decided to reassign said duties and responsibilities with the Police Department operation; and

WHEREAS, said assumption by the Police Department will be in effect upon the adoption of the fiscal year 1981-82 appropriation ordinance on July 21, 1981; and

WHEREAS, it has been deemed appropriate by the City Council to continue said Family Referral Program until the adoption of the fiscal year 1981-82 budget under the same terms and conditions as are set forth in the basic agreement, as amended; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, that the City Manager be, and he is hereby fully authorized to continue the Family Referral Program, enumerated in the above recitals, at the current level of funding and under the same terms and conditions as set forth in those agreements on file in the office of the City Clerk as Document No. RR-252766, as amended by Document No. C-00572, until such time as the fiscal year 1981-82 appropriation ordinance is adopted.

BE IT FURTHER RESOLVED, that the Auditor and Comptroller be and he is hereby authorized to pay such claims for services as may be submitted by the Family Referral Program and approved by the City Manager for services rendered under the extended agreement until such time as the fiscal year 1981-82 appropriation ordinance is adopted.
