WHEREAS, a certain slope easement was acquired without cost for the improvement of Balboa Avenue within the subdivision known as DALEY BOOTH BUSINESS PARK; and

WHEREAS, a portion of the easement being abandoned is excess; and

WHEREAS, the aforementioned slope easement will no longer serve the purpose for which it was acquired; and


WHEREAS, the City has no present or prospective public use for the slope easement, and the City Manager has recommended that the City abandon its interests therein; and

WHEREAS, the slope easement has a nominal value under the circumstances and BOOTH ENTERPRISES, INC., a California corporation, has paid all City costs in connection with processing the matter of quitclaiming the easement; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, as follows:

That the Mayor and City Clerk of said City be, and they are hereby authorized and empowered to execute, for and on behalf of The City of San Diego, a quitclaim deed, which is on file in the office of the City Clerk as Document No. RR-254583-/, quitclaiming to BOOTH ENTERPRISES, INC., a California corporation, all the City's right, title and interest in the slope easement, as more particularly described in said quitclaim deed.
