BE IT RESOLVED, By the Council of The City of San Diego as follows:

That the acceptance by the City Manager of those street and drainage easement deeds of AVCO COMMUNITY DEVELOPERS, INC., a California corporation, who acquired title as Ranch Bernardo, Inc., a California corporation, executed in favor of The City of San Diego, bearing date of August 14, 1980, copies of which deeds are on file in the Office of the City Clerk as Documents No. RR- 254587-1 and No. RR- 254587-2, granting to said City easements for street and drainage purposes in portions of Parcel 2 of Parcel Map No. 5404, as more particularly described in said deeds, be, and the same is hereby approved; and the land therein conveyed is hereby dedicated as and for a public street, and Parcel 1 is hereby named BERNARDO CENTER DRIVE and Parcel 2 is hereby named CAMINO DEL NORTE.

That the City Clerk shall cause the deeds and a certified copy of this resolution, attested by him under seal, to be recorded in the office of the County Recorder.
