That the City Manager be and he is hereby authorized and empowered to execute, for and on behalf of said City, a First Amendment to Agreement with LEIGHTON AND ASSOCIATES, INCORPORATED, to perform additional investigative work in connection with the Sonico Landslide, under the terms and conditions set forth in the First Amendment to Agreement on file in the office of the City Clerk as Document No. RR254589.

BE IT FURTHER RESOLVED, that the expenditure of not to exceed \$3,000 is hereby authorized from Sewer Revenue Fund 41506 solely and exclusively for the investigative work.

BE IT FURTHER RESOLVED, that the City Auditor is hereby authorized to transfer the sum of \$3,000 within Sewer Revenue Fund 41506 from the Unallocated Reserve (70697) to Sewer Engineering Services (70641).
