2. That the City Auditor and Comptroller is hereby authorized to transfer \$11,000.00 from CIP 27-009.1, RECONSTRUCTION OF CHILDREN'S POOL WALL TO CIP 23-825, LAKE RECREATION-WATER SUPPLY.
3. That the expenditure of \$38,000.00 from Capital Outlay Fund, 30245, CIP 23-825, LAKE RECREATION-WATER SUPPLY of the City of San Diego is hereby authorized solely and exclusively for providing funds for said project and related costs.
