BE IT FURTHER RESOLVED, that the City Auditor and Comptroller is hereby authorized to transfer the sum of \$50,350 from the Park and Recreation Bond Fund No. 725, CIP No. 22-808, Fiesta Island to CIP 22-024 South Shores Development.

BE IT FURTHER RESOLVED, that the expenditure of \$48,000 is hereby authorized from the Park and Recreation Bond Fund No. 725, CIP No. 22-024 for this purpose.
