WHEREAS, The Rancho Bernardo Recreation Council, Inc., a California non-profit corporation, located in the City of San Diego, has been carrying on an intensive program to promote and build a Regional Performing Arts Center in Rancho Bernardo; and

WHEREAS, the capacity of the Performing Center will be approximately 15,000 people including permanent seating under roof, plus seating on a grassy knoll; and

WHEREAS, the Performing Arts Center will attract performances of the San Diego Symphony, the San Diego Opera Company, the San Diego Ballet, well known musical groups as well as theatrical performances; and

WHEREAS, the Performing Arts Center will be one of the finest cultural attractions in the Southwestern United States, and

WHEREAS, the economy of the City of San Diego and San Diego County will benefit by added jobs and an increase in tourism,

BE IT RESOLVED, by the Council of The City of San Diego, that this Council, for and on behalf of the concerned citizenry, endorses the concept of establishing a Regional Performing Arts Center in Rancho Bernardo.
