WHEREAS, The City of San Diego currently has a policy of group life insurance (Policy No. GL 0370-000) with Pacific Guardian Life Insurance Company, Ltd., which is on file in the office of the City Clerk as Document No. RR-253060; and

WHEREAS, during "meet and confer" sessions with employee group representatives per Council direction, it was agreed that the City paid basic life insurance coverage would be increased from \$5,000 to one (1) times annual salary; and

WHEREAS, this change implements that agreement and relates to the Annual Leave and Long-term Disability programs; and

WHEREAS, the amended contract with our current carrier,
Pacific Guardian Life Insurance Company, Ltd., provides for this
increase, and reduces the premium rate from 18¢ to 16¢ per \$1,000
basic coverage effective July 1, 1981; and

WHEREAS, the amended language is set forth in detail as Endorsement #2 to the policy; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that the current contract between the City of San Diego and Pacific Guardian Life Insurance Company, Ltd., for City employee group life insurance (Policy No. GL 0370-000) on file in the office of the City Clerk as Document No. RR-253060 be, and the same is hereby amended by amending Policy page 2, entitled SCHEDULE OF INSURANCE, to increase the basic amount of coverage

from \$5,000 to one (1) times annual salary and concurrently reduce premium rates effective July 1, 1981, as more specifically set forth in Endorsement #2 to Policy No. GL 0370-000, a copy of which is placed on file in the office of the City Clerk as Document No. RR- 254622 .
