BE IT RESOLVED, by the Council of The City of San Diego as follows:

That a member of the Water Utilities Department, Wastewater Division, is hereby authorized to attend the Water Reuse Symposium II in Washington D. C., sponsored by American Waterworks Association and the office of Water Research and Technology (U.S. Department of the Interior) August 23-29, 1981, and to also visit four U.S. Government-sponsored aquaculture sewage treatment projects dealing with the use of water hyacinths in recycling of wastewater.

BE IT FURTHER RESOLVED, that the City Auditor is hereby authorized to transfer the sum of \$2,411 within the Sewer Operating Fund 41506 from the Unallocated Reserve 70697 to Metro Wastewater 70211, solely and exclusively for the purpose of providing funds for lodging, travel and miscellaneous expenses.
