WHEREAS, Section 8330 et seq. of the Streets and Highways

Code provides a procedure for the summary vacation of streets by

City Council resolution; and

WHEREAS, the State of California, Department of Transportation has requested that the alley located between I-805 and 47th Street, adjacent to Lots 46 through 57, Map 1390, be vacated; and

WHEREAS, the above-described alley has been impassable for vehicular travel for a period of five consecutive years, and no public money has been expended for maintenance of the alley during such period; and

WHEREAS, the City desires to reserve a certain easement for sewer and utilities over the alley to be vacated; and

WHEREAS, those properties adjoining the alley located between I-805 and 47th Street, adjacent to Lots 46 through 57, Map 1390, to be vacated will continue to have access; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

That the alley located between I-805 and 47th Street, adjacent to Lots 46 through 57, Map 1390, as more particularly shown on Drawing No. 14707-B on file in the office of the City Clerk as Document No. RC-254652, which is by this reference incorporated herein and made a part hereof, be, and the same is hereby ordered vacated.

BE IT FURTHER RESOLVED, that the City reserves and excepts from the foregoing vacation, a permanent easement for sewer and

utilities, as more particularly shown on Drawing No. 14707-B on file in the office of the City Clerk as Document No. RR.254652

BE IT FURTHER RESOLVED, that The City of San Diego hereby reserves and excepts from vacation and abandonment, easements and rights of any public utility pursuant to any existing franchise or renewals thereof, at any time, or from time to time, to construct, maintain, operate, replace, remove, renew and enlarge overhead or underground lines of pipe, conduits, cables, wires, poles and other structures, equipment and fixtures for the transportation or distribution of electrical or electronic energy and natural gas and for incidental purposes including access to protect the property from all hazards in, upon, over and across the above-described portions of streets to be vacated and abandoned.

That the City Clerk shall cause a certified copy of this resolution, with drawing, attested by him under seal, to be recorded in the office of the County Recorder.




