## RESOLUTION NO. R- 254654

A RESOLUTION APPROVING THE ORGANIZATION OF SHARP CABRILLO HOSPITAL AND MEMBERS OF ITS GOVERNING BODY, THE SALE BY DOCTORS HOSPITAL OF SAN DIEGO, INCORPORATED OF A HOSPITAL TO SUCH ORGANIZATION AND ACCEPTING SUCH HOSPITAL.

WHEREAS, by its Resolution No. 206158 heretofore adopted, this Council approved a proposal of Doctors Hospital of San Diego, Incorporated ("Doctors Hospital") for the acquisition, remodeling and conversion of hospital facility (the "Hospital Facility") within the City of San Diego through the corporation's issuance and sale of its First Mortgage Hospital Revenue Bonds (the "Bonds") and its Hospital Subordinated Limited Revenue Notes (the "Notes"); and

WHEREAS, Doctors Hospital proposed to sell the Hospital Facility to Sharp Cabrillo Hospital ("Sharp Cabrillo"), a California nonprofit corporation and a subsidiary of San Diego Hospital Association ("Sharp Hospital"), and Sharp Hospital would guarantee the payment of the Bonds and Notes; and

WHEREAS, the Bonds were issued pursuant to an Indenture of Mortgage and Deed of Trust (the "Indenture") pursuant to which a Corporation Grant Deed and a Bill of Sale were placed in escrow, to be delivered to the City when the Bonds and Notes had been paid; and

WHEREAS, Sharp Cabrillo will enter into a Supplemental Indenture and Deed of Trust (the "Bond Supplemental Indenture"), by which it will assume the obligations of Doctors Hospital

with respect to the Bonds and under which a Corporation

Grant Deed and a Bill of Sale from Sharp Cabrillo will be substituted for similar instruments placed in escrow by Doctors Hospital; and

WHEREAS, Sharp Cabrillo will enter into an agreement

(the "Note Agreement"), by which it will assume the obligations

of Doctors Hospital with respect to the Notes; and

whereas, the City has now received from Doctors Hospital draft copies of the following documents, the forms of which are on file with the Clerk of City as Document No. 254654:

- 1. Bond Supplemental Indenture;
- Note Agreement;
- 3. Articles of Incorporation of Sharp Cabrillo;
- 4. Bylaws of Sharp Cabrillo;
- 5. Corporation Grant Deed from Sharp Cabrillo;
- 6. Bill of Sale from Sharp Cabrillo;
- 7. Indemnity Agreement from Sharp Cabrillo to the City;
- 8. Indemnity Agreement from San Diego Hospital Association to the City;
- Indemnity Agreement from Doctors Hospital to the City;
- 10. Opinion Letter of Counsel for Doctors Hospital

  (Gray, Cary, Ames and Frye) to the City; and Opinion

  Letter of Dorsey, Marquart, Windhorst, West and

  Halladay to the City; and Opinion Letter of Counsel

for Sharp Cabrillo Hospital and San Diego Hospital Association (Scales, Elsworth and Corbett) to the City; and

11. Memorandum of transaction for recording.

NOW, THEREFORE, BE IT RESOLVED, by the Council of The City of San Diego as follows:

- 1. It is hereby found, determined and declared that the proposal of Doctors Hospital for the sale of the Hospital Facility and the assumption of the Bonds and Notes by Sharp Cabrillo will be in the interest of the residents of San Diego and will not impose any obligation or burden upon the City prior to the vesting of title to the Hospital Facility in the City.
- 2. The organization and purposes of Sharp Cabrillo specified in its Articles of Incorporation and Bylaws as set forth in the forms on file with the Clerk of City as Document No. 254654-3 and 4 are hereby approved.
- 3. The following named persons are hereby approved as directors of Sharp Cabrillo:



4. This Council, on behalf of The City of San Diego, hereby accepts from Sharp Cabrillo the transfer of the Hospital Facility as defined in the forms of the above-referenced documents which are on file with the Clerk of City as Document No. 254654 - 5, when all of the Bonds and Notes have been paid, and hereby agrees that title thereto will

vest in the City of San Diego upon such payment and after delivery to the City of San Diego of the Corporation Grant Deed and the Bill of Sale on the Hospital Facility, and hereby accepts the option to purchase the Hospital Facility before that date upon certain events and conditions specified in the Indenture.

- 5. By this action and adoption of this resolution, this Council hereby approves the Corporation Grant Deed and the Bill of Sale but it does not release or reconvey any right, title or interest the City has or may have in said Hospital Facility by reason of the prior transaction referred to in its Resolution No. 206158.
- 6. The City hereby approves the Bonds and Notes and the assumption thereof by Sharp Cabrillo as provided in the form of Bond Supplemental Indenture and Note Agreement in the forms of such documents on file with the Clerk of City as Document No. Rl-254654-l and -2
- 7. The City Manager is hereby authorized, on behalf of the City, to accept the Indemnity Agreement.
- 8. This resolution shall be come effective upon acceptance of the Indemnity Agreement referred to in Section 7.
- 9. Upon the approval of the City Manager or his designee, non-material and non-substantive modifications to the foregoing documents filed with the City Clerk may be made prior to August 31, 1981, so long as such modifications do not impair



or adversely affect the rights or interests of the City and so long as a copy of the finalized documents with any modifications approved by the City Manager or his designee are filed with the City Clerk.
