RESOLUTION NUMBER R- 254655

Adopted on JUL 20 1981

WHEREAS, Resolution No. R-251268 (February 25, 1980) authorized the City Manager to enter into an agreement with Yellow Cab Company of San Diego, Inc., to provide supplemental transportation services to the City's Dial-a-Ride Program; and

WHEREAS, the basic agreement has been amended twice to increase service areas, provide for fare adjustments to compensate for increased operating costs, and extend the term of the agreement; and

WHEREAS, Yellow Cab was authorized to provide transportation for medical trips for elderly and disabled persons registered with the Dial-a-Ride Program; and

WHEREAS, the passenger pays fifty cents and the Dial-a-Ride Program subsidizes the remainder of the trip of 6 miles or less; and

WHEREAS, the program offers an alternative to Dial-a-Ride clientele, when the existing service cannot accommodate their medical transportation needs; and

WHEREAS, a significant number of passengers are therefore able to be transported without additional vehicle acquisition by Dial-a-Ride; and

WHEREAS, the program has been quite successful and as a result, Dial-a-Ride and Yellow Cab desire to further extend the program until September 30, 1981; and

WHEREAS, it is further requested that mileage rate adjustments be approved to accommodate increased operating costs incurred by Yellow Cab; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, that the City Manager be and he is hereby authorized to execute for and on behalf of said City of San Diego a third amendment to the agreement with the Yellow Cab Company of San Diego, Inc., which is on file in the office of the City Clerk as Document No. RR-251268, dated February 25, 1980, as amended by Document No. RR-252434, dated August 12, 1980 and Document No. RR-253929, dated March 31, 1981, amending paragraphs 1 and 3 thereof, pursuant to the terms of the Third Amendment to Agreement on file in the office of the City Clerk as Document No. RR- 254655 .
