RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO AWARDING A CONTRACT TO THE SAN DIEGO GAS & ELECTRIC COMPANY FOR THE FURNISHING OF ELECTRICAL ENERGY AND SWITCHING TO THE SAN DIEGO STREET LIGHTING MAINTENANCE DISTRICT NO. 1 FOR A ONE-YEAR PERIOD.

WHEREAS, Resolution of Intention No. R- 254369, adopted JUN 8 1981, declared this Council's intention to enter into new contract with San Diego Gas & Electric Company for a one-year period to provide electrical energy and switching to San Diego Street Lighting Maintenance District No. 1; and

WHEREAS, pursuant to Chapter VI, Article 5, Division 5, Sections 65.0201 through 65.0222 of the San Diego Municipal Code a public hearing was held in conjunction with said contract awards; and

WHEREAS, this Council has considered all objections and protests made at said public hearing and has overruled and otherwise disposed of them; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, that the City Manager be, and he is hereby authorized and empowered to execute, for and on behalf of said City, agreement with SAN DIEGO GAS & ELECTRIC COMPANY for the furnishing of electrical energy and switching for a period of one year to the San Diego Street Lighting Maintenance District No. 1, in the City of San Diego, under the terms and conditions set forth in the agreement on file in the office of the City Clerk as Document No. RR-254658.
