BE IT RESOLVED, by the Council of the City of San Diego, as follows:

That the City Manager is hereby authorized to execute a permit with the United States Department of the Army in accordance with the requirements of Section 404 of the Federal Water Pollution Control Act, pursuant to which permit the City, under specified conditions, will be allowed to cause the filling and development of approximately 2.30 acres of land in and adjacent to the San Diego River, southerly of Camino del Rio North, west of Milly Way, under the terms stated in that permit, a copy of which is on file in the office of the City Clerk as Document No. RR- 254667-1!

BE IT FURTHER RESOLVED, that the Mayor and the City Clerk are hereby authorized and empowered to execute an Agreement Restricting Use of Land with the Fish and Wildlife Service, United States Department of the Interior, under the terms of which the City will be allowed to cause the filling and development of the above-described land in consideration of which the City agrees to cause the development of wetlands to replace the wetlands to be filled and developed and to restrict a total of 11.3 acres of Water Utilities land in and near the San Diego River as wetlands habitat, under the terms of that Agreement Restricting Use of Land on file in the office of the City Clerk as Document No. RR- 254667-2


BE IT FURTHER RESOLVED, that the City Manager is hereby authorized to execute an agreement with LPI/San Diego Associates, Ltd., which agreement will require LPI to improve and maintain the riparian habitat on certain lands north of Camino del Rio North, under the terms and conditions set forth in that

agreement on file in the office of the City Clerk as Document No. RR-
