That the Mayor and City Clerk of said City be, and they are hereby authorized and empowered to execute, for and on behalf of The City of San Diego, a quitclaim deed, a copy of which is on file in the office of the City Clerk as Document No. RR-254685-/, quitclaiming to THE ROMAN CATHOLIC BISHOP OF SAN DIEGO, a corporation sole, all of the City's right, title and interest in the sewer easement in Lot 1 of Mt. Carmel Heights Unit 1, Map 5972, as more particularly described in said deed.

3. That the City Clerk is hereby authorized and directed to deliver both deeds and a certified copy of this resolution, attested by him under seal, to be recorded in the office of the County Recorder.
