BE IT RESOLVED, by the Council of the City of San Diego, that the City of San Diego does hereby accept the generous contributions of the following organizations for the purpose of commissioning a bust of Jack Murphy to be displayed at San Diego Jack Murphy Stadium provided that if the total cost of the project is less than the total amount donated, the balance will be returned to the donors in the same proportion as their respective contributions bear to the total contributions:

BE IT FURTHER RESOLVED, that the City Auditor and Comptroller be and he is hereby authorized to deposit said contributions in deposit trust fund 63021 to be expended in accordance with this resolution.

BE IT FURTHER RESOLVED, that the City Manager be and he is hereby authorized to execute an agreement with Frank James Morgan, sculptor, for the creation of a sculptor bust of Jack Murphy for the sum of \$5,830 including sales tax, pursuant to the terms and conditions set forth in the agreement on file in the office of the City Clerk as Document No. RR- 254692.
