WHEREAS, the Suggestion Awards Committee has heretofore made certain recommendations to this Council; and

WHEREAS, the Council has reviewed said recommendations as well as the suggestions as presented; NOW THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, as follows:

That the following suggestion awards are hereby approved and the Auditor and Comptroller is hereby directed to issue warrants out of the General Fund for the following suggestions:

<u>NAME</u>	<u>DEPARTMENT</u>	<u>AMOUNT</u>	<u>SUGGESTION</u>
Glenn F. Awrey	Water Utilities	\$ 5,000	Mr. Awrey is an Associate Civil Engineer in the Plan Check Section of the Systems Division. He suggested that the sewer manhole at Bernardo Center Drive and Interstate 15 be removed and the sewer section be replaced with curved pipe. This is expected to save \$19,000 in costs to relocate the sewer.
Larry J. Schaller	General Services	\$ 4,440	Mr. Schaller is an Equipment Mechanic in the Equipment Division. He suggested that the extra transmission hydraulic line on the 5700 series trucks be removed. This is expected to save \$14,795 in the first year in costs for time and material.
Doyle F. Wheeler	Police	\$ 2,500	Mr. Wheeler is a Sergeant in the Northern Division. He suggested that the arrest report and case report accountability procedure be revised. This is expected to save \$50,210 in the first year in labor and overtime costs. This is a partial award pending a final 12 month review.
Richard L. Hoot	Police	\$ 1,795	Mr. Hoot is a Sergeant in the Traffic Division. He suggested that an abbreviated City equipment accident investigation program be instituted. This is expected to save \$6,803 in the first year in labor costs.
Robert L. Dodge	Police	\$ 1,000	Mr. Dodge was a Police Sergeant. He suggested that court cases originating by arrest by the Police Department be scheduled less often than five days per week. The first year's savings as a result of this suggestion were estimated at \$42,276 in costs for court appearance time.
